
# Dunbar Parking Management Consultation



We recognise the need for better parking solutions in Dunbar to manage high demand, especially at peak times. We're committed to improvements, and we want to hear from you!

By working closely with the Dunbar community, we aim to understand the issues affecting residents and businesses. Your feedback is important to find effective parking solutions in Dunbar. This work also aligns with our 2018 Local Transport Strategy and Parking Management Strategy.





## Why Dunbar?

To better understand the parking challenges faced in Dunbar, we engaged with the Community Council and Area Partnership. We also took time to review the findings from the Dunbar Trades Association Parking Survey.

# These engagements were productive and helped us to identify the following parking issues affecting the town:

- Insufficient car parking enforcement across the town
- Low turnover of parking spaces on the High Street and at the swimming pool car park, reducing options for shoppers and visitors
- Parking congestion around the train station, Countess Road and the surrounding area
- Lack of designated disabled car parking spaces
- Inadequate car park signage throughout the town
- Limited bicycle parking bays on the High Street
- Residents struggling to park close to their homes



## Definitions of parking management:

#### On-street parking:

Parking on a town street, e.g. the High Street or residential areas.

#### Off-street parking:

Parking in a car park away from the streets, such as at a library or town centre.

### Short stay parking:

Up to 90 minutes.

## **Medium stay parking:** Up to 5 hours.

**Long stay parking:** Up to 23 hours.

#### How could we address these issues?



#### Controlled parking:

Designate areas for short, medium, or long-stay parking with limited free parking time, followed by a charge for short stay parking.



#### **Enhanced enforcement:**

To increase the turnover of parking spaces, improve pedestrian safety by reducing illegal parking, and to boost the local economy.



#### Resident parking permits:

Allowing residents unlimited parking in designated areas with an annual fee.



#### **Healthcare worker permits:**

Healthcare providers would need to apply to the Council to receive permits for their staff.
